



# **State Medicare Information**

- There are **268,978** total Medicare beneficiaries in the State of Hawaii, which represents **18.94** percent of the total population.
- Alaska Total Annual Medicare Spending equals \$2.036 Billion.

# **Documented Shortage of Primary Care Health Professionals**

- According to the Health Resources and Services Administration, Hawaii has **27** total primary care Health Professional Shortage Areas (HPSA).
- More than **183.754** residents of Hawaii (**12.94** percent) live in a primary care HPSA. The national average is only 12 percent.

# **Hearing Loss Statistics**

- Of the more than 36 million Americans who experience hearing loss, 30 percent are 65-74 years old and 47 percent are 75 years old and older.
- Hawaii has **205,971** residents with some degree of hearing loss, which represents **14.5** percent of the state population.
- Untreated hearing loss results in a greater occurrence of other physical and mental conditions in elderly patients, substantially reducing the quality of life for older adults and increasing Medicare spending. Treated hearing loss enhances the quality of life and reduces health care costs.

## National Data on Older Adult Falls

- Every 18 seconds, an older adult is treated in an emergency room for a fall.
- The average hospitalization for a fall costs \$30,000 and the direct medical cost for falls in 2015 was \$50 billion.
- Among older adults (those 65 or older), falls are the leading cause of injury death. They are also the most common cause of nonfatal injuries and hospital admissions for trauma.
- Elderly falls are preventable as are their associated financial and societal costs. Audiologists reliably diagnose and treat the vestibular disorders and help prevent older adult falls.
